SENTENCE PRONOUNCEMENT AND ORDER

The State of Indiana appears by Prosecuting Attorney, Jarrod Holtsclaw, and the Defendant, Dale McNeal, Jr., appears in person, in custody of the Sheriff, and by attorney of record, Ellen Martin. Judgment of Conviction has been entered for the crime of Child Solicitation, a Level 5 Felony.

The Defendant, having been advised, also admits the allegations contained in the Petition to Revoke Suspended Sentence in Cause No. 28C01-0810-FA-000176. Violation found.

The terms of the sentence were fixed by the Negotiated Plea Agreement and the Court having accepted the Negotiated Plea Agreement is bound by its terms.

The Court now sentences the Defendant as follows:

28C01-2606-F5-000023 SENTENCE:

The Defendant shall be imprisoned for a term of three (3) years in the Indiana Department of Corrections. The Defendant shall receive credit for 80 actual days served ~~prior to sentencing.~~ *as of 9/16/2026. EJA*

The term of imprisonment will run **consecutively** to the sentence imposed in Cause No. 28C01-0810-FA-000176.

The Court now advises the Defendant that the Defendant is sentenced for not less than the earliest release date and for not more than the maximum possible release date.

The Defendant shall pay a fine in the amount of \$50.00. The Defendant is ordered to pay a sexual assault victim fee in the sum of \$500.00 and a Child Abuse Prevention Fee in the sum of \$100.00. The Defendant shall pay costs in the amount of \$189.00. The Defendant shall reimburse the public defender fund the sum of \$200.00. Defendant is determined indigent and will not face further incarceration for failure to pay.

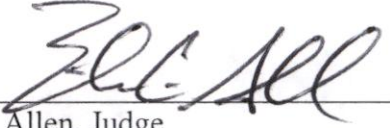
The State of Indiana moves to dismiss the Request for Repeat Sex Offender Sentence Enhancement. Request granted. The Request for Repeat Sex Offender Sentence Enhancement is dismissed.

28C01-0810-FA-000176 SENTENCE:

The Court revokes seven (7) years of the Defendant's suspended sentence. The Sentence shall be served in the Indiana Department of Corrections. This sentence will run **consecutive** to the sentence imposed under 28C01-2606-F5-000023. *Credit for -0- days served. EWA*

After the Defendant's release from incarceration, his probation shall be terminated as unsuccessful.
